Ticket Includes: Disney Park Hopper ticket with access to both parks for the day, entry to the exclusive Grad Nite Party at Disney California Adventure from 9:00 PM-1:00 AM and **mandatory bus ride transportation** on SMUSD buses to and from Anaheim, CA.

Note: Grad Nite ticket required regardless of passholder, Magic Key Pass.

During the day students will be at Disneyland/California Adventure with graduates from other schools as well as the general public. The Grad Nite Private Party Experience at Disney California Adventure is limited to Grad Nite event participants only. Grads will get exclusive access to Disney California Adventure park as it transforms into an immersive celebration.

Bus Assignments/Seat Assignment Request: At time of ticket purchase you may request one friend to ride with, but that friend must also request you in return. Participants are not allowed to switch buses at any point during the trip.

Check-in: 8:00 AM in MHHS parking lot/gym. Buses will promptly depart at 9:00 AM. If you miss departure your ticket is forfeited and no refund is provided.

Disneyland Policy & Expectations (2 pages)

My student (listed below) will be attending Grad Nite at Disneyland. I understand that certain rules and regulations will be in effect during Grad Nite. I acknowledge and agree that in the event my student violates any of the rules and regulations, they will be required to exit Disneyland immediately at which I agree to be responsible for picking up my student at Disneyland immediately. If my student is 18 years of age at the time of the event, they will be responsible to make arrangements for transportation from Disneyland.

Note: All student bags will be searched, students will pass through metal detectors prior to entering Disneyland, and students are subject to search and magnetometer by Disneyland while on the premises. In addition Anaheim police and canine unit will also be present conducting screenings for banned substances. If any banned substances are found, the matter will be turned over to the Anaheim Police Department for further action.

All students attending Grad Nite must be graduating high school seniors. Each student is responsible for their own ticket throughout the duration of the visit. Tickets are not transferable and will not be replaced if expired, lost, damaged or stolen. Students will receive an event wristband upon arrival.

To ensure a safe yet celebratory environment for schools attending Grad Nite, the items below are prohibited by Disneyland Grad Nite. This list is not all inclusive. Refer to the Disneyland Grad Nite site for a complete list (url below).

What items are prohibited from Grad Nite?

- All outside food and drinks including factory sealed water bottles
- Selfie sticks
- Recreational devices such as drones, remote control toys, wagons, skateboards, scooters, inline skates, shoes with built-in wheels, tricycles, unicycles, motorcycles, bicycles, and pogo sticks
- 2-wheeled vehicles, including Segway™ Human Transporters
- Suitcases, coolers or backpacks, with or without wheels, larger than 24" long x 15" wide x 18" high
- Alcoholic beverages and any illegal substances
- Weapons of any kind, or objects that appear to be weapons (also including toy blasters, squirt guns, etc.)
- Self-defense equipment (pepper spray, mace, stun guns)
- Sporting goods or equipment
- Restraining devices (e.g., handcuffs, zip ties) or any suspicious items (e.g., box cutters, razor blades, duct tape)
- Items that may be disruptive to other park guests (e.g., laser pointers, slingshots, stink bombs, air horns, wireless speakers, silly string)
- Professional cameras and recording equipment and large tripods
- Masks and makeup that could be construed as part of a costume
- Tobacco products including electronic cigarettes (e-cigarettes), vaping products, and medical marijuana.
- All types of markers

What items may students and chaperones bring to Grad Nite?

- Empty plastic or aluminum water bottles to be filled at water fountains throughout the parks.
- A purse, backpack, fanny pack, or other bag smaller than 24" long x 15" wide x 18" high
- Cell phone, phone charging cables and mobile battery chargers
- Jacket or sweatshirt for the early morning and nighttime hours when the weather may be cooler
- Money to pay for food and souvenirs throughout the day.
- Disneyland® Resort Grad Nite event ticket and photo ID

- 2. Zero Tolerance for possession of any type of weapon/substance per Ed code 48900 of any kind.**
- 3. All passengers belongings will be searched prior to boarding.**
- 4. All students are required and expected to follow all rules and regulations set forth District personnel by cruise line crew, security and chaperones. All passengers are expected to behave in a safe manner at all times.**
- 5. By signing below, I acknowledge and affirm that:**
 - I voluntarily assume all risks that the student may be exposed to COVID-19 virus and may be infected with the COVID-19 virus as a result of participation and that such infection may result in illness or disease which may lead to permanent injury or death.
 - This release includes any claims based on whether a COVID-19 infection occurs before, during, or after participation in this event.

In the event of a medical emergency or injury, I the undersigned, understand and agree that by participating in this event medical treatment could be delayed. In addition, the District will not be responsible for any loss, damage, delay or failure of performance arising or resulting from acts of war, acts of public enemies, or any unforeseen weather events or conditions.

The undersigned assumes all risks for personal injury, bodily injury, property damage and even death associated with the participation in this event that has an environment containing additional risks, dangers, and hazards. All participants must exercise extreme caution at all times in order to avoid or minimize the risk of damage, injury, and death.

California Education Code Section 35330(d) provides that all persons making a field trip or excursion shall be deemed to have waived all claims against the school district and State of California for injury, accident, illness or death occurring during or by reason of the excursion. I agree to hold harmless the San Marcos Unified School District, its officers, employees, representatives, agents, student and volunteers, including, but not limited to claims arising out of participation or any ordinary negligence.
